

FINANCIAL ASSISTANCE, CHARITY CARE AND DISCOUNT POLICY

DEFINITION AND PURPOSE:

Enloe Health is committed to providing financial assistance to patients who are uninsured or insured with high out-of-pocket costs to pay for medically necessary care. Enloe Health's mission statement, "To improve the quality of your life through patient-centered care" is the foundation for all determinations pursuant to this policy. Financial assistance determinations will be made within the broader scope of assisting patients and their families to obtain adequate and affordable insurance that provides an ongoing access to community health care services.

The purpose of this policy is to define the eligibility criteria for financial assistance, charity care, and discount payment for uninsured or insured with high out-of-pocket costs patients, and to provide administrative guidelines for the communication and implementation of this policy.

SCOPE:

This policy covers services provided by:

- Enloe Health.
- Home Medical Equipment (HME), Homecare and Hospice,
- · Hospital-based clinics, and
- Physician services when collections are paid to Enloe Health
 - A list of eligible physicians is available upon request from Patient Financial Services at 530-332-6300. This list will be updated, at a minimum, yearly in conjunction with annual review of this policy.

FINANCIAL ASSISTANCE, CHARITY CARE AND DISCOUNT POLICY:

The financial assistance described in this policy will be extended to eligible, financially qualified patients receiving emergent and/or medically necessary services. Services determined to be not medically necessary by way of provider attestation may not be eligible for financial assistance in accordance with State and Local regulation.

It is never the intent of Enloe Health to delay, defer, or deny emergent and/or medically necessary care. Please see hospital's *Management of Individuals Presenting for Emergency Services Policy*.

Eligibility for Financial Assistance, Charity Care and Discount Payment:

- A patient who is *uninsured* and whose family's income is at or below 450 percent of the federal poverty level (FPL) is eligible to apply for the hospital's financial assistance program.
 - An uninsured patient is a patient who does not have third party coverage from a health insurer, health insurance plan, Medicare, or Medi-Cal and whose injury is not a compensable injury for purposes of workers' compensation or automobile insurance.

- A patient who is *insured*, whose family's income is at or below 450 percent of the federal poverty level (FPL), *and* who has incurred medical expenses in the preceding 12 months that exceed 10% of their gross annual income is eligible to apply for the hospital's financial assistance program.
- Family size to determine federal poverty level is defined as follows:
 - → For persons 18 years of age and older, spouse, domestic partner, as defined in Section 297 of the Family Code, and dependent children under 21 years of age, whether living at home or not.
 - o For persons under 18 years of age, parent, caretaker relatives, and other children under 21 years of age of the parent or caretaker relative.
 - Children under 21, or any age if disabled (consistent with Section 1614(a) of Part A of Title XVI of the Social Security Act), whether living at home or not
- Family income shall be calculated based on the gross income, less disability income received, of the patient and each member of the patient's family unit as defined above
- All patients requesting Charity Care or Discount Payment will be required to:
 - o Complete, e-sign/submit an application via the MyChart patient portal or hard copy
 - Provide income and source of income in the form or recent pay stubs, prior year's tax return, disability or unemployment verification
- Further, for patients requesting Discount Payment, and for the sole purpose of documenting high medical expenses from other facilities, you may be required to:
 - Provide proof of medical expenses
 - Documentation may include but is not limited to bank or credit card statements, medical bills, and insurance Explanation of Benefits.
- Applicants will be required to participate in screening for Medi-Cal eligibility.
- If the patient receives a legal settlement, judgment, or award under a liable third-party action
 that includes payment for health care services or medical care related to an injury for which
 Enloe Health rendered care, in accordance with AB 2297, Enloe Health requires the patient
 or guarantor to reimburse the hospital for those related health care services up to the
 amount reasonably determined for those services.
- In the event that a patient fails to comply with the above requirements, the ineligible account(s) will be forwarded to a collection agency and will be handled in compliance with all state and federal regulations. The agency may cancel back account(s) at any time if alternate forms of documentation supports eligibility for financial assistance.
- Approved Charity Care and Discount Payment applications will be documented in the patient
 accounting system and remain valid for 6 months. Discounts may be taken automatically up
 to the approval level already authorized. If an account is greater than the already approved
 dollar threshold, it will need to be submitted for further approval. It is at Management
 discretion that a new application be requested if there is reason to believe the patient's
 financial situation may have changed.

Financial Assistance, Charity Care and Discount Payment Guidelines:

- Financial Assistance will be provided to approved, financially qualified patients, as defined above, on a sliding scale basis, using the current published Federal Poverty Levels (FPL) as guidelines. Financial assistance discounts will be granted using the following criteria:
 - o If family income is less than 150 percent FPL: Free Care
 - If family income is 151 percent to 300 percent FPL: Co-payment of \$100 per eligible account.
 - If family income is 300 percent to 400 percent FPL: 100 percent of Medicare fee schedule, or the self-pay discount of 55% whichever is less.
 - If family income is 401 percent to 450 percent FPL, and current cumulative patient out-of-pocket amounts are greater than \$15,000: 150 percent of Medicare fee schedule, or the self-pay discount of 55% whichever is less.
- Financial assistance discounts will be approved as follows:

Under \$3,000
 Patient Financial Services (PFS) Staff

\$3,001 - \$10,000
 \$10,001 - \$35,000
 PFS Supervisor
 PFS Manager

o \$35,001 - \$75,000 PFS Director or Sr. Director Rev Operations

o Over \$75,000 Chief Financial Officer (CFO)

 Discounts under Enloe Health's Financial Assistance, Charity Care and Discount policy are not intended to routinely offset share of cost obligations, deductibles, or coinsurance under government programs. Exceptions may be approved as follows:

Under \$10,000:
 \$10,001 - \$35,000:
 PFS Supervisor
 PFS Manager

Above \$35,000:
 PFS Director or Sr. Director Rev Operations

- Following a determination of eligibility, an individual whose FPL is <450%, will not be
 charged for emergency or other medically necessary care an amount greater than the
 amounts generally billed (AGB) to individuals with coverage. For the purpose of this policy,
 AGB is defined as: an amount not to exceed Medicare Fee Schedule for the same service.
- Following a determination of eligibility, any previous payments made by the patient on the
 account in question that exceed the patient's remaining responsibility by \$5, and where the
 payment was made within the last five (5) years, will be refunded, including interest, within
 30 days.
- Patients who have veteran's benefits, are treated for non-service related conditions and who allow us to bill their medical insurance as primary will automatically be granted financial assistance for any estimated patient balance. Amounts must be approved as follows:

o Under \$10,000: PFS Supervisor

o Greater than \$10,000: PFS Manager or Above

 Patients may be presumptively found eligible for Financial Assistance. Examples include, but are not limited to, deceased patients with no estate and patients documented as homeless or transient may be granted financial assistance without meeting the above requirements. Patients on state or federal assistance who receive medically necessary services not covered by their assistance program may also be granted financial assistance without meeting requirements.

- Non-covered and denied services provided to Medicaid-eligible patients are considered a form or charity care. Medicaid patients are not responsible for any forms of patient financial liability and all charges related to services not covered, including all denials, are charity care. Examples may include, but are not limited to:
 - Services provided to Medicaid patients with restricted Medicaid (i.e., patients that may only have pregnancy and emergency benefits, but receive other hospital care)
 - Medicaid-pending accounts
 - Medicaid or other indigent care program denials
 - Charges related to days exceeding a length of stay limit
 - Medicaid claims (including out of state Medicaid claims) with "no payment"
 - Any service provided to a Medicaid patient with no coverage and no payment
- On occasion, there may be circumstances where patients may not be able to pay the
 discounted amount. In these special circumstances, discounts may be further negotiated to
 an amount that considers the patient's essential living expenses and diminished ability to
 pay. The additional discounts may be granted up to designated approval levels:

o \$100 - \$35,000 PFS Manager

o \$35,001- 75,000 PFS Director or Sr. Director Rev Operations

o Above \$75,000 CFO

- Extended payment plans up to 48 months may be offered as necessary for the uninsured
 patient to meet their financial obligation. Extended payment plans for financially qualified
 patients shall be interest free and will be negotiated between Enloe Health and the qualified
 patient. Absent an agreement between the two parties; monthly payments shall be
 calculated to not exceed ten percent of the patient's family income for a month, excluding
 deductions for essential living expenses.
 - In the event a patient defaults on their extended payment plan for 90 consecutive days, the payment plan will be declared inoperative, but at no time will the patient responsibility exceed the qualified discounted amount.
- Should the hospital's use of extraordinary collection activities (ECA's) come into question, Enloe Health's Compliance Committee has the final authority and responsibility for determining that the hospital had made reasonable efforts to determine whether a patient was eligible for financial assistance prior to initiating extraordinary collection activities (ECA's).
- Following approval for financial assistance discounting, patients that have made payments prior to determination may be eligible for refund based on the following criteria:
 - Payments must be in excess of the discounted amount due in total across all approved discounted accounts.
 - Payments must have been made within the prior five (5) years from day of approval notice. Payments will be evaluated at the individual account level to determine refund eligibility.

Patient Notification and Appeal Rights:

- Uninsured patients will be provided with applications for Medi-Cal and/or Healthy Families, information on enrollment to the California Health Benefit Exchange, and contact information to a local consumer assistance center housed at the legal services offices at the time of registration or no later than at the time of discharge.
- Notices will also include information for patients who need help understanding the billing and payment process. They will receive contact information for Health Consumer Alliance at 888-804-3536 or www.healthconsumer.org.
- Uninsured patients will be provided a plain language summary of the financial assistance guidelines, the application form and contact number at the time of registration or no later than at the time of discharge.
- Billing notices to uninsured patients will include contact information for Medi-Cal and the California Health Benefit Exchange as well as the contact number and website for the financial assistance program.
- A patient is required to complete and submit an application for financial assistance as described above.
 - Eligibility determination will be made within 60 days of the submission of all required documentation.
 - At the time a decision is made approving or denying financial assistance, a letter will be sent to the patient notifying the patient of the hospital's decision.
 - Documentation of financial assistance determinations will be kept on file in the Patient Financial Services Department for two years.
 - Patient statements will reflect the financial assistance discount.
- Incomplete applications will be held a minimum of for 60 days from filing or 240 days from first post discharge billing. Following this time, patients may still apply for financial assistance, but may be asked to complete an updated application and re-submit income verifications.
- Patients who disagree with the financial assistance determination have the right to appeal
 the decision. Appeals must be made in writing to the CFO, Enloe Health. The CFO will
 render a decision within 60 days.
- Patients will also be notified of their rights under the Hospital Bill Complaint Program, including how to access support at www.hospitalbillcomplaintprogram.hcai.ca.gov.

SELF PAY DISCOUNT:

- Self pay discounts will be granted to all uninsured patients that do not qualify for Charity Care or Discount Payment.
 - A 55 percent discount is applied if payment is received prior to any bad debt referral
 Note: These percentages are subject to review and change each fiscal year.

• Extended payment terms may be offered at the discretion of Enloe Health. In these cases, up to six months of interest-free terms may be granted.

HOSPITAL BASED PHYSICIAN CHARITY CARE AND DISCOUNT POLICY:

- Physicians will provide discounts to uninsured patients or insured patients with high out-ofpocket costs who are at or below 400 percent of FPL.
- Enloe Health's Patient Financial Services (PFS) Department acts as a billing agent for Chico Emergency Physicians as well as Enloe Specialty Physicians (ESP).
- PFS is authorized to make the eligibility determination for charity care and discounted payment. The hospital's application process will include all physician services billed by Enloe Health. The same eligibility criteria will apply for hospital and physicians.
- The Patient Notification and Appeal Rights as noted in this policy will also apply to the physician accounts.
- A list of eligible physicians is available upon request from Patient Financial Services at 530-332-6300. This list will be updated, at a minimum, yearly in conjunction with annual review of this policy.

Financial Assistance, Charity Care and Discount Payment Guidelines:

- If the patient is uninsured or insured and with high out-of-pocket costs and family income is at or below 400 percent FPL, the patient will owe no more than 100 percent of the Medicare fee schedule.
- On occasion, there may be circumstances where patients who qualify for discounted service
 may not be able to pay for the discounted amount. In these special circumstances,
 discounts may be further negotiated to an amount that considers the patient's diminished
 ability to pay. The additional discounts may be granted up to designated approval levels:

Under \$10,000
 PFS Supervisor

Greater than \$10,000
 PFS Manager or Above

RELATIONSHIP TO COLLECTION PRACTICES:

- It is the intent of Enloe Health to comply with all state and federal regulations.
- Enloe Health's Financial Policy outlines the types of collection efforts contracted collection agencies may/may not take to collect on past-due hospital, emergency and specialty physician accounts.
 - It is recognized that as part of the charity care and discount process, patients may break their promise to pay from time to time.

FINANCIAL ASSISTANCE, CHARITY CARE, AND DISCOUNT POLICY 7 of 18

- In these instances, patients with past-due financial assistance obligations, not less than 90 consecutive days delinquent, may be referred to an outside agency in the same manner as any other patient with an unpaid past-due account.
- Prior to referral, Enloe Health will comply with all state and federal regulations; making a reasonable attempt to contact the patient by phone, giving notice in writing that the extended payment plan may become inoperative, offering the opportunity to renegotiate the extended payment plan, providing notice of financial assistance availability for those that qualify and giving appropriate notice prior to initiating any extraordinary collection activities (ECA's). For specific billing and collections guidelines please refer to the hospital's Financial Policy.
- However, in no instance will any patient receiving financial assistance under this
 policy be subject to abusive telephone collection practices, liens being placed on their
 primary residence, wage garnishments, or involuntary court hold orders.

PUBLIC NOTICE OF FINANCIAL ASSISTANCE:

- Enloe Health will post notices regarding the availability of financial assistance, charity care
 and discount payment in all patient registration areas, in patient handbooks, at its PFS
 Department, and on its website at www.enloe.org.
- Notices shall be posted in languages where a patient population of 5% or 1,000 individuals is
 determined through an annual review of the language demographic information collected
 during the registration process. Currently, notices are published in English and Spanish. In
 addition, Enloe Health shall annually publish a statement of charity care and discount
 payment assistance in its community benefits report. A telephone number will be available
 for persons with questions to inquire about Enloe Health's financial assistance program.
- Notices shall contain language that includes emergency and specialty physician services.

Note: This policy is a combination of the *Financial Assistance, Charity Care* and *Financial Arrangements* policies.

- 4. If you are insured with high medical costs, please provide documentation of patient liability for medical providers other than Enloe Health (*if applicable/Discount Payment Only*).
 - Documentation is used for the sole purpose of determining high medical costs and may come from but not limited to: checking or credit card statements, medical billing statements and insurance Explanation of Benefits
- 5. Include a copy of any denial letters/statements from Medi-Cal (if available)

Note: If you have questions about these requirements, please contact our office.

Those requesting charity care or discounted payment should make every reasonable effort to provide the above requested documentation and in a timely manner. Failure to do so may affect our ability to consider and make determination on this application for financial assistance.

We will process complete applications within 60 days of receipt and will notify you of our decision.
