Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

Patient Received Information in Writing

These percentages and inputs are stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. General acute care hospitals are required to report several HCAI All-Cause Unplanned 30-Day Hospital Readmission Rates, which are broadly defined as the percentage of hospital-level, unplanned, all-cause readmissions after admission for eligible conditions within 30 days of hospital discharge for patients aged 18 years and older. These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. Plan to address disparities identified in the data

Health Equity Planned Actions to Address Identified Top Disparities:

To understand why the identified populations are having increased readmissions there needs to be additional information to help identify the "why" related to these readmissions to assist in creating a meaningful intervention. Each of the actions planned below address person centered care, patient safety, social drivers of health, effective treatment, care coordination and access to care.

Actions Planned:

1. Gain better understanding around the "why" of readmissions and barriers to health:
 - a. Specific: By October 31, 2025, Care Coordination will consistently assess, document, and track the causes of readmissions (from social determinants to effective care concerns), reporting qualitative and quantitative data weekly at the Hospital Safety Huddle and monthly at the Clinical Excellence Committee.
 - b. Measurable: Data on readmission causes will be collected and reported.
 - c. Achievable: Care Coordination currently assesses and reports; this goal formalizes and refines the reporting frequency and venues.
 - d. Relevant: This directly contributes to understanding and addressing readmission drivers.
 - e. Time-bound: By October 31, 2025.
2. Multidisciplinary assessment of data and development of health disparity plans around readmissions:
 - a. Specific: By December 31, 2025, a multidisciplinary team at the Clinical Excellence Committee will implement a monthly review process for readmission data, creating, implementing, and evaluating interventions to reduce readmissions.
 - b. Measurable: Interventions created, implemented, and evaluated monthly; readmission rates will

be tracked (PDSA model).

- c. Achievable: This builds on existing data review and intervention processes.
 - d. Relevant: Directly addresses top health care disparities outcome of readmissions.
 - e. Time-bound: By December 31, 2025 (for process establishment), with bi-monthly evaluation ongoing.
3. Listening session with Asian population to gain understanding of healthcare needs/barriers:
- a. Specific: By February 2026, Community Health will conduct a Listening Session targeting the Asian community to identify health barriers related to readmissions, with data reviewed by March 15, 2026, and an intervention created and implemented by April 15, 2026, to decrease readmissions in this group.
 - b. Measurable: Listening session conducted, data reviewed by specific date, intervention implemented by specific date, and readmission rates for the Asian population will be tracked.
 - c. Achievable: Community Health can assist with this using established Community Health Needs Assessment formats.
 - d. Relevant: Directly addresses the identified disparity of readmissions in the Asian population.
 - e. Time-bound: February 2026 (session), March 15, 2026 (data review), April 15, 2026 (intervention implementation).
4. Review other data sources, such as event reports and patient experience data, to assess health disparities:
- a. Specific: By December 31, 2025, event reports and patient experience data will be assessed annually to identify causes related to health disparities, specifically language, culture, and ethnicity, to inform disparity reduction efforts.
 - b. Measurable: Annual assessment completed, with findings documented.
 - c. Achievable: For the event reports, this is an existing annual process that can be focused on health disparities. For patient experience data this is a new process with agreement between patient experience leader and health disparity leader to meet quarterly to start looking at the data through a disparity lens.
 - d. Relevant: Helps identify underlying causes of health disparities through untapped data resources.
 - e. Time-bound: By December 31, 2026 (for the annual assessment).
5. Communication of health disparity identification data, actions put in place and evaluation of interventions to leaders within the hospital: will be reported to the Senior Leadership Team at the Monthly Quality meeting. Additionally this information will be shared at the all manager Quality Meeting quarterly.
- a. Specific: By October 31, 2026, health disparity data, implemented actions, and evaluation outcomes will be consistently reported to the Senior Leadership Team at monthly Quality meetings and shared quarterly at the all-manager Quality Meeting.
 - b. Measurable: Reporting occurs monthly to the Senior Leadership Team and quarterly to all managers.
 - c. Achievable: This integrates into existing meeting structures.
 - d. Relevant: Ensures accountability and broad awareness of health equity initiatives and progress.
 - e. Time-bound: By October 31, 2026 (for establishment of consistent reporting).

Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment,

care coordination, and access to care.

Person-centered care

In our commitment to person-centered care, guided by our core values of compassion, inclusion, integrity, excellence, and collaboration, our healthcare ministry has taken significant steps to address health disparities and build trust within diverse communities. We recently re-established a patient advisory committee with a strong focus on diverse representation, recognizing that over 70% of the community we serve is Latino, with many being mono-lingual Spanish or Mixteco speakers. To bridge communication gaps and advocate for vulnerable populations, we developed a robust interpreter program where interpreters also connect individuals to essential community resources. While internal data from event reports, ethics consults, and quality case reviews have illuminated health disparities, the raw demographic data in our EHR hasn't fully captured the needs of the Mixteco-speaking community due to the stigma associated with identification. A crucial finding emerged from our bioethics consultation process: a profound lack of trust among the Mixteco-speaking population, particularly pregnant mothers, which has led to refusals of medically indicated, life-saving treatments. A subsequent survey of 42 Mixteco speaking community members revealed that this population deeply needed a voice and to be understood as a people to foster community and trust. In response, over the past year, more than 270 staff members have undergone Cultural Humility training, emphasizing the profound impact of language, culture, healthcare beliefs, practices, and caregiver biases on trust and access to care, specific to the Mixteco speaking culture.

Additionally, over the last year all managers have received training in implicit bias, and clinicians are trained in trauma-informed care. The Suspected Abuse Task Force regularly convenes to discuss cases and identify areas for ongoing learning, all contributing to our enhanced performance in person-centered care. Most recently our physician over the Medical Safe Haven program presented to the Emergency Department physicians about the human trafficking safe haven program as well as the importance of trauma informed care for health equity for this very vulnerable population. The next group to be presented to will be a group of community physicians and leaders over our community clinics

Patient safety

Our hospitals are committed to providing safe, high-quality care to all patients. We recognize that achieving true patient safety requires a proactive and data-driven approach to identify, understand and dismantle inequities that disproportionately impact vulnerable populations. Our commitment has been to embed health equity principles into our patient safety work, ensuring our efforts lead to measurable improvements in safety outcomes for all individuals, regardless of their background.

To deepen our understanding of healthcare inequities in patient safety, data aggregation from our incident reporting system includes extracting demographic information as well as health inequities and disparities. Analysis of the data is reviewed by a multidisciplinary team, including representatives from our Health Equity Committee, patient safety leadership, and relevant clinical departments.

Safety events are investigated and reviewed using the Event Investigation & Analysis (or Root Cause Analysis) and Apparent Cause Analysis with an equity lens. When patient safety events occur our investigations go beyond immediate causal factors to explore underlying systemic inequities and social determinants of health that may have contributed.

Patient safety initiatives, policies, and practices are designed with the diverse needs of our patient population in mind by using input, where appropriate, from our community partners and patient representatives.

We are committed to continuous learning and improvement in our patient safety equity work by adapting strategies based on new data, research, and community feedback. Our transparent sharing of successes and challenges demonstrates accountability, fostering a highly reliable environment focused on equitable outcomes and ensuring all patients benefit from the highest standards of safety and care.

Areas of Work Within Patient Safety and Equity:

- Recognizing the critical importance of early signs of infection, a quality and patient safety project was launched to provide education on infection signs in languages that best represent our community, empowering individuals to seek timely medical attention before conditions escalate.
- In-person, culturally sensitive Mixteco and Spanish translators have been implemented and utilized as part of the healthcare team. This critical resource eliminates language barriers and respects diverse cultural contexts, ensuring that all patients can fully engage in their care and that safety information is understood, preventing misunderstandings and promoting optimal outcomes.
- Understanding and mitigating falls is crucial for prevention of patient harm. To address this important health concern with our diverse community, we recognized the need for fall risk and prevention education materials specifically in Spanish. The materials and education ensures that language is not a barrier to receiving essential safety information, allowing Spanish-speaking patients and their caregivers to fully engage in strategies that promote balance, mobility and a safer environment.

Addressing patient social drivers of health

In 2024 our inpatient nurses fully screened 80% of all patients with a Social Needs Screening Tool in the EHR. Needs were identified around transportation and food insecurity. In CY 2024 we collected a total of 11,084 responses to questions regarding social needs, 12.3% reported difficulties with transportation and 8.2% reported food insecurity. Social workers are sent an automatic consult in the EHR after screening for those most in need. Individuals are connected to community resources around food and transportation. Additionally, our Transition Care Center has community health workers who can assist with navigating these needs.

Our Mixteco health disparity working group found from the 42 surveyed that basic needs, such as food, water, diapers, are in need. Our Community Health grants have shared these needs with community partners with the hope that non-profits in the area will develop a project to address these needs that could be funded by our grants.

Our facilities participate in the "replate" food donation program. In the Cy 2024 we provided over 8,200 pounds of surplus food translating into 6,900 meals delivered to our local community in need via the Central Coast Rescue Mission Alliance.

Some of our employees, who are part of our community, are living paycheck to paycheck and one crisis can create situations like having to live in their car, unable to provide food for their family, unable to get to work due to the car needing to be fixed. There is a Friendship Fund, created by employees giving to this fund. The money is requested when there is a crisis and is not required to be paid back. Over \$80,000 was given to employees in need in 2024.

The Community Health team has many health promotion/prevention programs and all are taught in English and Spanish. Most recently we are adding a Mixteco interpreter to these sessions to include the ability for understanding of important health information and resources for this highly vulnerable population.

Community Health works with the High Risk Infant Follow-up clinic and case manages these families as community health workers. Two staff from CH have 12 appointments twice a month to help manage and navigate these families. They assist with getting the family basic needs, transportation, as well as being a support person, accompanying the family through the difficult journey.

Performance in the priority area continued

Performance across all of the following priority areas.

Effective treatment

At Dignity Health Marian Regional Medical Center (MRMC), our mission is to provide high quality compassionate care for all who seek it. We strive to provide equitable care to every patient, recognizing and proactively mitigating the impact of social determinants of health and systemic biases.

Care coordination

At Dignity Health Marian Regional Medical Center (MRMC), our mission is to provide high quality compassionate care for all who seek it. We strive to provide equitable care to every patient, recognizing and proactively mitigating the impact of social determinants of health and systemic biases.

- We utilize evidence-based guidelines for chronic and acute diseases. Outcomes of guideline adherence are differentiated by race, ethnicity, language, socioeconomic status, and geographic location to identify and close equity gaps in chronic disease management.
- Our Electronic Health Record (EHR) is designed to capture patient-reported demographic data and health-related social needs. Access to care

The most recent community health needs assessment (CHNA) identified four top priorities, all having an impact on barriers to accessing care. The four priority areas are:

1. Culturally sensitive and accepting healthcare trusted by the community.
2. Readily available healthcare and navigation assistance in patients' spoken language.
3. Unmet vital conditions including transportation, finances, housing (including the unhoused population), education, the environment, and childcare.
4. Access to improved behavioral health, including substance use disorder treatment, and navigation of services with a special emphasis on the unhoused population.

In 2024 the hospital delivered several programs and services to help address these needs. These included: Cancer prevention and Screenings; Cardiovascular Disease and Stroke lectures and screenings; Chronic Disease Self-Management workshops; Diabetes Prevention and Management, and Diabetes Education Empowerment Program (DEEP); and A Matter of Balance Fall Prevention program. The Street Medicine Program was expanded to three outings a month to address access to care needs of the unsheltered.

Additionally, there is strong collaboration with our Transition Care Center to create services needed after discharge for the highly vulnerable populations. This might be follow-up with a community health worker, or connection to community resources to help with transportation, food or other vital needs.

For 2024 there was an increase of 18% on medically underserved cancer patients that were screened and referred to psychosocial support, nutritional counseling, nurse navigator support, social services support and support classes. The lung screening program screened 1,419 and 9 new cancer cases were identified. Transportation services assisted 3,595 transports to medically underserved.

With our community grants we funded projects that addressed barriers to access to primary care, behavioral health and oral health in fiscal year 2024.

The Medical Safe Haven program (those impacted by human trafficking) touched the lives of 52 victims of human trafficking and provided over 111 clinical visits to these individuals' physical and mental health needs.

The Behavioral Wellness Center, a crisis stabilization unit developed by the hospital to address the lack of access to mental health services for those in crisis, provided access to care for over 900 individuals experiencing a mental health crisis in 2024.

Herencia Indigena (HI), the Mixteco speaking interpreter services and advocacy lead over 6 cultural awareness trainings for over 270 individuals from the hospital and clinics to help build understanding of this culture and build trust. HI provided over 12,000 outpatient sessions and 8,000 inpatient sessions to increase access to care in the individual's language.
