Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

Patient Received Information in Writing

The second HCAHPS quality measure is the percentage of patients who reported receiving information in writing on symptoms and health problems to look out for after leaving the hospital. These percentages and inputs are stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. General acute care hospitals are required to report several HCAI All-Cause Unplanned 30-Day Hospital Readmission Rates, which are broadly defined as the percentage of hospital-level, unplanned, all-cause readmissions after admission for eligible conditions within 30 days of hospital discharge for patients aged 18 years and older. These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. The monitoring of readmission patterns helps us identify specific barriers faced by disparate populations so that we can refine discharge workflows, strengthen CHF-specific interventions, and target supportive services earlier in the stay.ð

Insights from SDoH screening and readmission interviews are used to adjust care plans before discharge, ensure resources like transportation or medication access are secured, and reduce preventable readmissions among vulnerable patients.ð

Adventist Health and Rideout (AHRO) has identified that 8 of the top 10 disparities involve all-cause 30-day readmissions, with chronic diseases and social inequities contributing significantly to these outcomes. To address these disparities, AHRO is implementing multidisciplinary workflow enhancements for patients with chronic conditions, specifically CHF, in disparate populations. Key actions include risk identification, screening for social drivers of health, ensuring follow-up appointments, optimizing medications, providing patient education, and monitoring compliance and outcomes across care teams. The measurable objective is to reduce all-cause 30-day readmissions among disparate populations by 5%. Specific timeframes for implementation and monitoring are defined within ongoing quality improvement initiatives.ð
