## Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

## Patient Received Information in Writing

## HCAI All-Cause Unplanned 30-Day Hospital Readmission Rate

General acute care hospitals are required to report several HCAI All-Cause Unplanned 30-Day Hospital Readmission Rates, which are broadly defined as the percentage of hospital-level, unplanned, all-cause readmissions after admission for eligible conditions within 30 days of hospital discharge for patients aged 18 years and older. These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. #### Plan to address disparities identified in the data

Disparity 1-6 and Population Impact: Expected Payor: Other. The payer "other" disparity rate 20.8% with a reference rate for Medicare populations of 14.2%, for All Cause 30 Day Unplanned Readmissions, creating a return ratio of 1.5. Race and/or Ethnicity: Black or African American. The Black or African American population disparity rate 18.1% with a reference rate for Hispanic or Latino populations of 12.7% for All Cause 30 Day Unplanned Readmissions, creating a return ratio of 1.4. Race and/or Ethnicity: White. The White populations disparity rate 15.1% with a reference rate for Hispanic or Latino populations of 12.7%, for All Cause 30 Day Unplanned Readmissions, creating a return ratio of 1.2. Expected Payor: Medicaid. The Medicaid disparity rate 16.2% with a reference rate for Medicare populations of 14.2%, for All Cause 30 Day Unplanned Readmissions, creating a return ratio of 1.1. Sex Assigned as Birth: Female. Disparity Rate 15.6% while the male reference group is 14.4%, for All Cause 30 Day Unplanned Readmissions, creating a return ratio of 1.1. Age: 50-64 years. The age range of 50-64 disparity rate 15.1% while the 65 and older reference group is 14.1%, for All Cause 30 Day Unplanned Readmissions, creating a return ratio of 1.1. Analysis: The "Other" payer category consists of invalid or not provided insurance, county indigent programs, government, and workmen's compensation programs. Analysis of the "other" payer group show disparities for male patients at 22.7% as compared to female patients at 11.1% and are predominately Black or African American at 40% or White 20% as listed as their race/ethnicity compared to the statewide average. Black and African American populations have a higher rate of 30-Day Unplanned Readmissions with a return ratio of 1.4. Further analysis within that patient population show that there are disparities for males 20.7%, age range of 18-34 33.3%, and self-pay or "other" payer groups 50%. White populations have a higher disparity for 30 Day Unplanned Readmission with analysis of that disparity showing female patients make up 16.7% and the age group 35-49 make up 18.6% of the disparity group. Medicaid populations have a higher disparity of 14.2% as compared to the statewide average, with analysis showing that Medicaid patients have a higher rate of race/ethnicity White of 18.3% and behavioral health indicators showing mental health disorders at 20% and substance use disorders at 19.5%. For readmissions by sex, female population 15.6% in comparison to males. Further stratification of the disparities show a significant portion of



the population is from the 35-49 age group 17.1%. The patient population age range of 50-64 have an identified disparity when compared to the 65 and older population. Further analysis of the 50-64 age range population shows that 29% of that population has "other" or self-pay payer listings and have a higher rate of substance use disorder behavioral health indicators 23.8%. Action Plans: Risk stratification by disparity shared with the multidisciplinary committees to help target the specific identified disparities within the readmission reduction performance improvement work. Discharge planning to include SDOH screening review and provide interventions to help address the health equity barriers identified to the individual patient. Rounding prior to patient discharge by the care management team to confirm communication preference prior to disposition for the care transition team needs. Follow up appointments made prior to discharge for all high-risk readmission patients within the provider recommended time frame. Meds to Beds program exploration and development to address access barriers for high-risk readmission patients. Medication delivery options shared as part of the discharge planning that deliver to surrounding rural communities. Follow up calls to help assist with care coordination post disposition are made within 48hrs of discharge for all high-risk readmission patients. Objective: Reduce All-Cause Unplanned 30-Day Hospital Readmission Disparity Rate for payer of "Other" by 1% within 24 months. Reduce All-Cause Unplanned 30-Day Hospital Readmission Disparity Rate for race/ethnicity of Black and African American by 1% within 24 months. Reduce All-Cause Unplanned 30-Day Hospital Readmission Disparity Rate for race/ethnicity White population by 1% within 24 months. Reduce All-Cause Unplanned 30-Day Hospital Readmission Disparity Rate for payer of Medicaid by 1% within 24 months. Reduce All-Cause Unplanned 30-Day Hospital Readmission Disparity Rate for the Female sex by 1% within 24 months. Reduce All-Cause Unplanned 30-Day Hospital Readmission Disparity Rate for age range population 50-64 by 1% within 24 months. Timeframe: All action plans are to begin by January 2026 with a multidisciplinary committee leading improvement through the duration of the action plan.

## **Performance in the priority area**

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

### **Person-centered care**

Adventist Health Tehachapi Valley recognizes the great importance of patient-centered care and incorporates the individual's goals, concerns, values and right for self-determination within the care planning process. The key performance activities in place to incorporate patient centered care are as follows.

- Collection of social determinants of health data starts at the beginning of a person's hospitalization visit and is incorporated within the patient data profile capture.
- Captured social determinate of health data is reviewed by the discharge planning care management team as part of their discharge planning assessment early in the patient stay. Any needs identified, are given resources to address the patient's specific barriers.
- Multidisciplinary care rounds occur daily at the patient bedside with the care team including, but not limited to, attending care provider, nurses, care management, pharmacy, rehabilitation services, nutrition, wound care, palliative care, and respiratory therapy. This comprehensive team rounding together with the patient allows for open dialogue between the care team and patient for goals for the daily hospital care while also planning for patients needs when transitioning to their post hospital setting.

- Personalized care planning and discharge planning is tailored to the patients physical, emotional and wellbeing health needs respecting the patients cultural, spiritual ad personal preferences.
- Various language interpreter, translation and American Sign Language video services are utilized for communication with the patient based on the identified preferred language assessed from the start of the patient visit. This service reduces any barrier to communication with the patient regarding their care, treatment, and instruction.
- Spiritual support services are provided on-site as well as on-call to meet the individual spiritual and emotional needs of the person including all faith and backgrounds.
- The online Patient Portal is available to the patient during and after their stay allowing for secure access to test results, visit summaries and other records.
- Patient education preferences are assessed and taken into account with delivery of instruction. The care team utilizes multimodal education including, but not limited to, handouts, verbal, teach-back and digital to best meet the patient's individual needs.
- The patient experience is a priority to the various service lines within the hospital setting. Patient Experience Surveys are sent, collected, analyzed and shared for continued performance improvement activities to improve patient care.

#### Patient safety

As an organization, Adventist Health Tehachapi Valley consistently strives to achieve high reliability through application of just culture for accountability, implementation of culture of safety, and use of data systems for improved standardization. Safety events are analyzed for improvement opportunities and standardization of process, assessments, and interventions are developed with evidenced based practice with the goal to minimize risk, prevent errors and provide quality of care.

- Harm reduction strategies are a part of the organization systems and processes, and each occurrence is thoroughly reviewed and addressed with the goal to prevent recurrence, including but not limited to, Patient Safety Indicators, Hospital Associated Conditions, medication safety, infection prevention, environment of care, mortality, readmission, and sepsis.
- Organizational quality improvement program is integrated through the hospital services and departments with quality and safety a priority of focus.

#### Addressing patient social drivers of health

Adventist Health Tehachapi Valley assessed patient's social needs with the disposition planning beginning on arrival to the organization. The data is collected and utilized in the care planning process with early assessment of the patient's potential barriers to care and social determinants of health. Interventions are then applied to help reduce the social barriers to their health and wellbeing with their care transition. The organization has sustained a high assessment participation rate that exceeds the 2024 year target.

- Screening of health-related social needs include, food insecurity, housing instability, transportation, utilities and safety concerns. These screenings are utilized in the discharge care planning process and appropriate resources given to assist with the patient need.
- Cal-Aim is a program that is utilized, funded by the California Department of Health Care Services that assigns a community health worker to the individual therefore given assistance to address barriers to care including but not limited to, access to medications, delivery of medications, transportation to and from appointments, ongoing contact for health care needs, assistance with food programs, financial assistance programs, educational programs, dependent care programs and many more services. The goal is to graduate the individual once the barriers to their social determinants of health care needs are met and sustained.
- Grants for Narcan program that allows free access to lifesaving substance abuse lifesaving agents.
- Substance Use grant from Kern County the goal of having another resource to see patients with

substance abuse needs included but not limited to, in person visits, follow up calls, rehabilitation needs, and community programs for recovery.

- Transition of care visits are arranged with the rural health clinics when patients do not have a primary care provider set up to help address their immediate post discharge care needs and establish care with a provider.
- Resources are provided based on a person's social determinants to their health including but not limited to, local and state financial programs in the area, charity care for any healthcare billing support for those who qualify, transportation, church vouchers for hotels, local food banks, meals on wheels, community rehabilitation and recovery services, senior center referrals, durable medical equipment needs, and indigent resource packets. Any safety or security needs are thoroughly assessed with targeted interventions to help support the individual.

## **Performance in the priority area continued**

Performance across all of the following priority areas.

### **Effective treatment**

Adventist Health Tehachapi Valley delivers timely and effective evidenced based care. In recognition of our rural health challenges, Adventist Health Tehachapi Valley has many health services not often seen in critical access hospitals, thus bringing specialty care to an underserved population.

- To address emergency visit throughput with timely and efficient care a Fast Track program was developed to provide service for lower acuity patients. This provided space to treat the individual in a more private and dignified manner while also serving their health needs in a timely manner.
- Sepsis recognition software is utilized in the triage setting to help identify potential sepsis patients for quicker evaluation and standardized treatment.
- Standardized screenings, assessments, and interventions help address the behavioral health concerns that present from the community for treatment.
- Outpatient services prioritize throughput and experience for ease of access and comfortability of the patients served.
- Dialysis services for inpatient and emergency care are made available, a needed service allowing patients to remain close to home for their hospitalized care who require this service.
- SWING services are provided at the hospital setting for non-acute needs when patients need additional rehabilitation prior to their transition to home.
- Surgical services are provided both for scheduled outpatient and emergent needs providing the care needed closer to patient's home communities.
- A variety of Tele-Health services are utilized in both the hospital and outpatient setting to bring specialty services to the communities Adventist Health Tehachapi Valley serves.

### **Care coordination**

Adventist Health Tehachapi Valley supports care coordination ensuring the clinical care teams communicate effectively setting up the patient for a successful care transition from the hospital setting. The efforts taken to coordinate care help improve patient outcomes.

- Prior to patient discharge from the hospital setting, discharge planning is utilized including appointments made prior to discharge based on the provider recommendations according to evidence-based practice.
- After discharge, follow up calls are made to inpatients within 48hrs to address any barriers or questions they may have encountered after leaving the hospital setting.
- Patients who return to the emergency setting also receive follow up calls by the Community

Health Manager to help address their social determinants of health and any additional barriers to their healthcare navigation.

- During the hospitalization there is daily multidisciplinary rounding that occurs at the patient bedside allowing for care coordination between the patient and the clinical team.

#### Access to care

Adventist Health Tehachapi Valley provides access to health care services in a rural health setting that has many access to care challenges. The services available allow for an underserved population to receive needed healthcare that would otherwise not be attainable.

- There are several Adventist Health Rural Clinics in the communities who serve as primary care for many populations. The clinics also have transition of care appointments available for patients who do not have primary care allowing for their immediate post hospitalization need to be met while also establishing primary care to serve their ongoing healthcare needs.
- The mobile health clinic is available to serve the rural health communities with primary care access challenges.
- Adventist Health Tehachapi Valley actively participates and supports several events in the community helping to support wellness, education, while enhancing community engagement and trust.
