Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

Patient Received Information in Writing

CMQCC Nulliparous, Term, Singleton, Vertex (NTSV) Cesarean Birth Rate

The CMQCC Nulliparous, Term, Singleton, Vertex (NTSV) Cesarean Birth Rate is defined as nulliparous women with a term (at least 37 weeks gestation), singleton baby in a vertex position delivered by cesarian birth. These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. A key priority is addressing disparities in all-cause unplanned 30-day hospital readmissions and 30-day pneumonia mortality

Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

Person-centered care

Patient-centered care remains a fundamental priority for the facility. From the moment of arrival and throughout the hospital stay, every patient is screened for language preferences, and qualified interpreters are readily available to ensure effective communication. Interpreter services are accessible 24/7 by phone, and discharge instructions are translated to support patient and family understanding. This approach empowers patients and their families to participate actively in care planning and decision-making. Patient voices are further integrated through bedside shift-change handoff reports and interdisciplinary care team rounds at the bedside. Informed consent practices ensure patients are fully aware of the benefits and risks of their procedures, while discharge

planning incorporates patient and family preferences in selecting post-acute care providers. The facility partners with a patient experience vendor to collect and analyze patient experience data across race, ethnicity, and language. This data is applied to enhance cultural and religious sensitivity, particularly during end-of-life care. Social workers are engaged proactively based on nursing assessments of patient needs, with pastoral care available upon request. Through collaboration with case management and social work teams, patients are routinely screened for food insecurity, housing instability, transportation challenges, intimate partner violence, financial hardship, stress, physical activity, and social connections. When needs are identified, social worker consultations are triggered, and appropriate community resources are arranged prior to discharge. The facility's commitment to equity and social responsibility has been recognized nationally. It received an (A) grade for social responsibility from the Lown Institute Hospitals Index for 2025 to 2026 and earned (A) grades in Health Equity, Patient Outcomes, Clinical Outcomes, Inclusivity, and Pay Equity. Based on this performance, the hospital is ranked 27th out of 258 hospitals in California and within the top 300 hospitals nationwide on the social responsibility metric. This recognition reflects the organization's dedication to providing equitable, patient-centered, and community-focused care.

Patient safety

Patient Safety is the facility's highest priority, with focused efforts on reducing risks, preventing harm, and ensuring equity in care. Safety metrics including falls, medication errors, pressure ulcers, and readmissions are tracked across demographic groups to identify trends and address disparities. A key initiative targets reducing readmissions for congestive heart failure (CHF) and pneumonia. Special attention is given to vulnerable populations, including homeless patients, through coordinated referrals for housing, bedside medication delivery, timely post-discharge appointments, and partnerships with community food networks. From January 2024 to June 2025, 95% of qualified CHF patients were discharged with a follow-up appointment, significantly improving continuity of care. Patient and family engagement is reinforced through inclusive rounding practices that respect cultural, religious, racial, ethnic, age, and gender considerations. Families are consistently informed of care plans, condition changes, and safety concerns to strengthen trust and transparency. For staff, the facility invests in equity-focused training and professional development. Clinical teams receive continuing education on cultural competence, social determinants of health, and safe discharge planning, while leaders complete training in diversity, equity, inclusion, and allyship. These integrated strategies support for vulnerable patients, transparent patient engagement, and staff development demonstrate the facility's commitment to safe, equitable, and high-quality care delivery.

Addressing patient social drivers of health

Addressing Patient Social Determinants of Health remains a top priority for the facility. In alignment with The Joint Commission National Patient Safety Goals, leadership collaborated with internal teams, the Information and Technology Department, the Quality Improvement Organization (QIO) Health Services Advisory Group, Inc. (HSAG), and patient experience vendors to analyze disparities and health equity data. This analysis highlighted several areas requiring focused attention: Tobacco Use.

7,894 out of 36,663 patients and 732 out of 36,663 patients aged 65 years and older from June 2022 to June 2023 were identified at high risk of tobacco use. The facility continues to assess patients on tobacco risk and provide resources.

Readmissions Data

HSAG analysis of all-cause unplanned readmissions (12/2021 to 11/2022) concluded Asians had the highest readmissions at 25%. Elder patients were more likely to be readmitted compared to younger patients. Of 313 Medicare discharges in 2022, 186 returned to the facility, with 127 readmitted to other hospitals. Facility readmissions (July 2021 to June 2024) for congestive heart

failure remain above the national average at 25.7% (vs. 20%), and pneumonia readmissions are 25.3% (vs. 16%). For 2025 through June, CHF readmission to the same facility is 12.5% and pneumonia 19%. Data monitoring continues for disparity trends

Patient Experience

CMS-submitted adjusted 2021 and 2022 data revealed that 17% of patients aged 65+ scored lower on Explanation of New Medicine, 13% scored lower on New Medicine Side Effects, and 8% scored lower on Understood Medicine Purpose compared to younger patients. This project was prioritized for health equity, focusing on improving discharge education and medication understanding. Key initiatives included (1) discharge education led by primary nurses with structured medication guides, and (2) pharmacist-led support for high-risk patients. Cardiac-specific initiatives reinforced this focus, with nurses providing discharge and cardiac care education. Patient experience data showed improvement: in 2021, 77% of patients aged 65+ reported usually or always receiving information on the purpose of medication; this increased to 83% by June 2025. Similarly, 64% reported usually or always receiving information on side effects in 2021, improving to 67% by June 2025. These metrics confirm positive progress, and the facility remains committed to ongoing monitoring and targeted equity-based interventions

Performance in the priority area continued

Performance across all of the following priority areas.

Effective treatment

Providing evidence-based, timely, and effective treatment is a priority of the facility. As per facility policy, all patients, irrespective of race, age, gender, ethnicity, or financial status, receive safe and equitable care. Based on the analysis, health disparities were identified that prompted the clinical team to build equity into clinical decision support. As mentioned above, performance metrics have shown variation by subgroup. For example, based on the readmission analysis for congestive heart failure patients, it was noted that Medi-Cal patients constituted 67% of the total readmissions during the first half of 2025. To address this, the facility is implementing EMR alert modifications and targeted staff education to close the gap. Upon arrival and during hospitalization, the nursing team assesses patients for social determinants of health, which triggers social worker consultation when needed

The case management team then works closely with patients to connect them to appropriate community resources. A post-discharge appointment is arranged before patients leave the facility to ensure continuity of care. Additionally, case management has initiated a new process that includes follow-up phone calls after discharge to check on patients and address unmet needs. To support this initiative, weekly case management meetings are conducted with clinical directors, case managers, and providers to review patients who meet disparity-related criteria and to monitor outcomes

Care coordination

Care Coordination is a priority of the hospital to ensure care is organized across providers, settings, and time. Upon arrival, the emergency room staff initiates the social determinants of health assessment, which triggers social worker consultation for high-risk patients in the areas of food insecurity, housing instability, transportation needs, stress, intimate partner violence, financial resource strain, physical inactivity, and social connections. Discharge planning begins at admission, with social workers collaborating with patients and families to identify post-discharge needs. The Case Management team coordinates with insurance companies and community partners to offer resources and ensure a smooth transition back into the community. For example, at discharge, homeless patients are provided with access to Orange County housing resources, connected with CalAIM to find stable housing, and referred to Illumination for continuity of care. The facility also

partners with Active Pharmacy to deliver medications at bedside prior to discharge, while providing weather-appropriate clothing and arranging transportation. For uninsured patients, the admitting team initiates Medi-Cal screening and applications for emergency medical coverage, ensuring hospital care and essential post-discharge follow-up. This proactive approach reduces gaps in care and avoids preventable readmissions. Uninsured patients, who often face overwhelming medical bills, are guided toward state resources for financial assistance. By aligning medical treatment with social support, the hospital ensures comprehensive care coordination that addresses both clinical and non-clinical needs, ultimately improving patient outcomes and community health

Access to care

Access to care is a priority of the facility, achieved through timely and culturally appropriate services. From January through August 2025, the facility treated patients of which 56% were Medicare and 38% were Medi-Cal. Homelessness, lack of insurance, and underinsurance remain significant barriers to care; therefore, the clinical team partners closely with case management and social workers to bridge care gaps following discharge. For patients with mental health needs, the facility collaborates with City Net for shelter placement, outreach, and engagement. During this period, the facility recorded 22,390 emergency room visits, contributing to longer wait times and saturation of services. To address this, the facility implemented Fast Track Care, an initiative that enables patients to schedule emergency room visits in under two minutes via QR code, text, or the hospital website. This innovation allows patients to bypass long waits while enabling the facility to better anticipate patient volumes and allocate resources effectively
