Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

Patient Received Information in Writing

These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. Measurable Objectives: Reduce 30-day all-cause readmissions by 15% over the next 2 years. Ⓓ

Disparity 6 and 7 Plan: Race and/or Ethnicity Readmit Disparities (Asian and Black or African American VS Hispanic or Latino) Ⓓ

Population Impact: Asian and Black or African American population Ⓓ

Action Plan: Provide discharge instructions and health education in culturally relevant formats and languages. Address barriers such as housing, food security, and access to medications that disproportionately affect African American and Asian men. Ⓓ

Measurable Objectives: Reduce 30-day all-cause readmissions by 15% over the next 2 years. Ⓓ

Disparity 10 Plan: Expected Payer (NTSV) C-Section Birth Rate by Expected Payor (Private Insurance VS Medicaid) Ⓓ

Population Impact: Pregnant people at least 37 weeks gestation who had a Cesarean Section birth during their first pregnancy who also have Private Insurance. Ⓓ

Action Plan: 62% of our Labor and Delivery nurses have completed Spinning Babies education. This education teaches the nurses and expecting pregnant people gentle exercises and body positions that encourage optimal fetal positioning. For babies in a breech position, these techniques may encourage them to turn head-down naturally, thus reducing the need for Cesarean Deliveries. Ⓓ

Measurable Objectives: Reduce the volume of cesarean section births carried out for non-medical related reasons over the next year.

Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

Person-centered care

Person-centered care is a holistic approach to health delivery that places the individual and their values, preferences, and lived experiences at the center of decision-making. Rather than focusing solely on disease management, person-centered care emphasizes dignity, respect, and collaboration between patients, families, and providers to achieve the best health outcomes. Ⓓ

Ⓓ
A critical component of person-centered care is language access services. Effective communication is essential for safe and equitable healthcare. We offer interpreter services, translation of health materials, and bilingual staff to ensure that patients with limited English proficiency can fully understand their care plans and actively participate in decision-making. Clear communication builds trust, reduces errors, and promotes patient confidence in the healthcare system. Improvements include expanding the language offerings our discharge instructions can be printed in for an enhanced discharge experience.

Patient safety

Patient safety is central to delivering high-quality care in hospitals. The High Reliability Organization (HRO) model, adapted from industries such as aviation and nuclear power, provides a framework for hospitals to operate safely and effectively in complex, high-risk environments. The goal is to create a culture where harm is rare, errors are anticipated, and systems are designed to respond quickly

when risks arise. ð

ð

By applying the HRO model our hospital transforms safety from a set of isolated initiatives into an embedded culture of reliability and trust. Through vigilance, resilience, and inclusive teamwork, patient harm is minimized, care quality improves, and hospitals become safer places for every patient. Our decreasing number of Hospital Acquired Infections (HAIs) for the last 2 years is reflective of our commitment to patient safety.

Addressing patient social drivers of health

Our hospital recognizes that 90% of our top 10 disparities in patient outcomes are directly attributable to 30-day all cause readmissions. ð

Our health system is committed to advancing health equity by reducing avoidable hospital readmissions through evidence-based, patient-centered interventions. Recognizing that social and structural barriers disproportionately affect vulnerable populations, we aim to ensure all patients- regardless of race, income, language, or housing status- receive equitable support during their transition from hospital to home. To address disparities, we have implemented three core strategies: •

1. Follow-up appointments prior to discharge, scheduling follow-up appointments before patients leave the hospital ensures continuity of care, reduces missed visits, and provides timely monitoring of recovery. This practice particularly benefits patients with limited health literacy or transportation challenges by reducing the burden of navigating appointment scheduling independently. ð

2. Transition care clinics, transitional care clinics provide a structured bridge for high-risk patients between hospital and primary care. These clinics focus on medication reconciliation, education, and reinforcement of discharge instructions, which are critical for patients managing multiple chronic conditions. By incorporating culturally appropriate communication and interpreter services, we reduce barriers that underserved populations may face in understanding and adhering to care plans. ð

3. Follow-up phone calls for high-risk patients. Within 48-72 hours of discharge, high-risk patients receive personalized phone calls from care coordinators or nurses. These calls address medication concerns, clarify instructions, and identify social needs such as access to food, housing, or transportation. When social barriers are identified, patients are linked with community-based resources, thereby addressing upstream determinants of health that influence readmission risk. ð

ð

Addressing social determinants of health (SDoH) is essential to improving patient outcomes beyond clinical care. Our hospital has prioritized this effort, achieving a screening rate of over 80% for all inpatient stays during the 2024 calendar year. These screenings ensure the most vulnerable of our patients are assessed for critical social needs such as housing, food security, and transportation. By identifying these factors early, we can connect patients with community resources and reduce barriers that impact recovery and overall well-being. This high level of screening demonstrates our commitment to whole-person care and advancing health equity. The hospital sponsors through strategic partnership with Kern Community Foundation a county-wide network of community-based organizations to utilize a referral platform technology (Unite Us) to coordinate an individual's social needs. At present there are 582 programs to serve patients and community members accessible through the platform, and the hospital issued 205 referrals for 50 clients in 2024. The hospital hopes to grow its patient referrals by 15% through 2025. ð

ð

Our Community Health Improvement Program is designed to support the well-being of vulnerable populations by addressing both medical and non-medical needs. The program includes a community health initiative that assists uninsured and underinsured individuals with health insurance enrollment, improving access to care. Community wellness programs provide education and support for chronic disease management, empowering individuals to take charge of their health. Additionally,

the homemaker care program offers training for non-medical in-home supportive service workers for seniors/adults with disabilities, improving their quality of life and strengthening workforce development. ð

To ensure our strategies reduce disparities, we will monitor readmission rates stratified by race, ethnicity, language, and insurance status. We have implemented a multi-faceted approach to address these readmission disparities including advanced risk assessments and reassessments, patient centered interventions, and being proactive when screening patients for social determinants of health upon admission and throughout their hospitalization. ð

ð

By embedding equity into care transitions, our plan not only reduces readmissions but also narrows gaps in access to outcomes. Through proactive follow-up, transition support, and patient -centered communication. We are building a system where every patient, particularly those most at risk, has the resources and support needed for a safe recovery. Our goal is to decrease identified readmission disparity gaps by 15% over the next 2 years.

Performance in the priority area continued

Performance across all of the following priority areas.

Effective treatment

Effective treatment is care that works, is delivered safely and consistently, and leads to better health outcomes for all patients. Mercy Hospital demonstrates effective treatment of sepsis through evidence-based protocols that improve patient outcomes and reduces mortality. Increased compliance with the SEP-1 bundle, ensuring timely and evidence-based interventions. As compliance has risen, we have observed a steady decline in sepsis-related mortality rates. By embedding equity into our approach, we ensure that all patients-regardless of race, language, or background-receive consistent, high-quality care that improves survival and outcomes.

Care coordination

Our hospital is committed to advancing health equity by improving care coordination and addressing disparities in access, communication, and outcomes. We recognize that patients from underserved populations, including those with limited English proficiency, low income, or complex chronic conditions, face disproportionate barriers during care transitions. To reduce avoidable readmissions and improve outcomes, we are embedding equity-focused strategies into every step of the care continuum. ð

ð

We prioritize seamless transitions between hospital, primary care, and specialty services. Prior to discharge, high risk patients receive follow-up appointments scheduled with their primary and specialty providers, reducing the burden of navigating the healthcare system independently. We also utilize transitional care clinics to provide short-term, intensive support until long-term providers assume care. These clinics reinforce treatment plans, reconcile medications, and address patient questions in a timely and culturally responsive manner. ð

ð

Our standardized discharge planning protocols are designed to ensure every patient leaves the hospital with clear, actionable next steps. This includes comprehensive medication reconciliation and education, with materials available in multiple languages. Inclusion of family members or caregivers in discharge discussions to reinforce understanding and support adherence. Assessments of social determinants of health, such as housing, transportation, and food access, with referrals to community partners as needed, and follow up phone calls within 48-72 hours for high risk patients to address immediate concerns and prevent complications.ð

To ensure equity, we engage interpreters, patient navigators, and community partners to support vulnerable populations, ensuring that no patient is left behind due to language or social barriers. Patients and families are viewed as active partners in care, empowered to participate in shared decision-making and raise concerns. Đ

By aligning care coordination with equity principles, we are creating a system where patients experience smoother transitions, greater confidence in their care, and fewer avoidable hospitalizations. Our commitment is not only to reduce readmissions but also to close gaps in care, improve trust, and ensure that every patient receives safe, reliable, and person-centered care across the continuum. Đ

Areas for improvement include enhancing communication across care settings and expanding follow-up support for high-risk patients.

Access to care

Increasing access to care is essential for advancing health equity, improving patient outcomes, and reducing avoidable hospital utilization. Access goes beyond the availability of services-it includes affordability, timeliness, cultural responsiveness, and the ability of patients to navigate the healthcare system effectively. Đ

We have expanded our care coordination team, scheduling follow-up appointments before discharge, utilizing transitional care clinics, and providing care navigation services to help those patients with chronic conditions transition seamlessly to primary and specialty care. Đ

Offering interpreter services, translated materials, and culturally responsive communication ensures that patients with limited English proficiency can fully participate in their care. We also collaborate with local organizations to provide transportation, housing assistance, or social support to address non-medical barriers that impact access. Helping patients understand insurance options and connecting them to financial support programs reduces cost-related delays in seeking care.Đ

Patient and family engagement is critical to improving access. We empower patients through health education, shared decision-making, and clear discharge instructions to enhance their ability to manage conditions and navigate follow-up care. By including families and caregivers, hospitals strengthen support systems that help patients overcome barriers outside of the clinical setting. Đ

Increasing access to care requires a holistic, equity-driven approach that integrates clinical excellence with social support, communication, technology, language access, and community partnerships. Hospitals can reduce disparities, improve trust, and ensure that all patients-regardless of background or circumstance-have the opportunity to achieve their best health. Mercy Hospital is committed to increasing access in rural areas by offering community outreach programs that provide health screenings, preventive care, and education. Through mobile clinics and local partnerships, we reduce barriers such as distance and limited provider availability, while connecting residents to follow-up and primary care. These efforts strengthen community trust and help reduce disparities in rural health outcomes.
