## Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

## Patient Received Information in Writing

These percentages and inputs are stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. General acute care hospitals report the Pneumonia Mortality Rate by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. ## HCAI All-Cause Unplanned 30-Day Hospital Readmission Rate

General acute care hospitals are required to report several HCAI All-Cause Unplanned 30-Day Hospital Readmission Rates, which are broadly defined as the percentage of hospital-level, unplanned, all-cause readmissions after admission for eligible conditions within 30 days of hospital discharge for patients aged 18 years and older. These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. ## Plan to address disparities identified in the data

### Overview & Population Impact

Our hospital recognizes that readmission disparities disproportionately impact specific populations, including older adults, individuals with chronic conditions, non-English speakers, and patients from low-income communities. Analysis of our top 10 disparities show higher readmission rates among patients in high Social Vulnerability Index (SVI) areas compared to the hospital average. These disparities lead to avoidable care utilization, higher costs, and increased patient burden.

The most impacted groups include:

- Medicaid-insured patients with limited outpatient follow-up access
- Patients with limited English proficiency (LEP) who face care coordination and health literacy barriers
- Patients with multiple chronic conditions requiring intensive follow-up

### Goal

Reduce the 30-day readmission rate disparity between the highest-risk group and the hospital average by at least 5% within 24 months.

### Measurable Objectives & Timeframes

#### 1. Data Stratification & Monitoring – 0–6 months

- o Implement enhanced tracking of readmissions by race, ethnicity, language, payer, ZIP code, and SVI.
- o Review stratified data quarterly through the Quality and Equity Committee to identify disparities and refine interventions.

#### 2. Enhanced Discharge Communication – 3–12 months

- o Provide discharge instructions in preferred languages for 100% of LEP patients by month 12.
- o Apply "teach-back" verification for 90% of all discharges by month 9 to confirm understanding.



### 3. Post-Discharge Follow-up Expansion — 6–18 months

- o Launch a community health worker (CHW) and nurse navigator program for the top 15% highest-risk patients by month 6.
- o Complete follow-up calls within 72 hours post-discharge for 90% of this cohort by month 12.

### 4. Improved Outpatient Access & Social Support — 6–24 months

- o Partner with local FQHCs, home health, and transportation providers to secure follow-up appointments before discharge.
- o Reduce no-show rates for target groups by 15% within 18 months.

### 5. Performance Measurement & Reporting — Ongoing; annual review

- o Monitor readmission disparities quarterly and report progress to leadership and community partners annually.
- o Evaluate success based on:
  - Disparity reduction from 25% higher-than-average to  $\leq 20\%$  within 24 months
  - Patient-reported understanding of discharge plans  $\geq 90\%$  by month 12
  - Sustained improvement for two consecutive years

#### Evaluation

We will use rolling 12-month averages to monitor trends and adjust strategies. Stratified data will drive targeted interventions, ensuring cultural and linguistic appropriateness. Progress will be validated through quantitative readmission metrics and qualitative patient feedback.

#### Commitment

This plan integrates clinical quality improvement with social determinant interventions to reduce disparities and improve care continuity. Through data transparency, culturally responsive communication, and strengthened community partnerships, we are committed to ensuring all patients have equitable opportunities for recovery and reduced risk of avoidable readmission.

## Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

### Person-centered care

#### Performance in the Priority Area of Person-Centered Care

Our hospital is committed to care that is respectful of and responsive to each patient's preferences, needs, and values—recognizing that equitable outcomes require addressing the unique barriers faced by the broad range of patient populations we serve. Person-centered care is embedded in our mission through policies, training, and improvement efforts that prioritize dignity, cultural respect, and patient partnership.

#### Care Planning & Shared Decision-Making

We involve patients and families at every stage through bedside rounding, decision aids, and interdisciplinary conferences. Care plans account for social and cultural contexts, such as dietary and religious needs, and include coordination with providers, case managers, and family to ensure smooth transitions.

#### Culturally & Linguistically Appropriate Services (CLAS)

We provide professional interpreters and translated materials in the top preferred languages to ensure patients with limited English proficiency understand and can follow their care plans, reducing communication barriers and supporting adherence.

## Respect, Dignity, and Autonomy

All staff receive annual training in trauma-informed care, state-mandated modules in implicit bias, and instruction in patient rights. Real-time feedback and person-centered reviews guide actions to ensure all patients feel respected and involved in their care decisions.

## Care Transitions & Follow-Up

A structured follow-up program supports patients at highest risk of readmission, including those with complex needs, Medicaid coverage, or high social vulnerability. Follow-up calls, medication reconciliation, and pre-scheduled outpatient appointments are paired with community health worker support to address social needs that may affect recovery.

## Patient & Family Advisory Involvement

Our Patient and Family Advisory Council, with broad representation from across our community, reviews policies, materials, and services. Their input has shaped improvements in signage, patient-provider communication, dietary options, and visiting policies to better meet patient needs.

## Performance Monitoring & Commitment

We track person-centered care through patient surveys, complaints, follow-up rates, and disparity-focused outcome reviews. By integrating cultural humility, shared decision-making, and proactive support, we ensure care is both clinically effective and person-centered, advancing our health equity goals and improving recovery experiences for all patients.

## Patient safety

### Performance in the Priority Area of Patient Safety

Our hospital prioritizes patient safety as a core element of quality care, ensuring that all patients receive treatment in a safe environment, free from preventable harm. We approach safety with a proactive, system-wide strategy that integrates clinical best practices, continuous monitoring, and a person-centered lens to address risks that may disproportionately affect certain populations.

### Safety Culture & Staff Engagement

We foster a culture where all staff are empowered to identify and report safety concerns without fear of blame. Daily safety huddles, multidisciplinary rounds, and open communication channels allow us to address issues quickly and share lessons learned across departments.

### Evidence-Based Practices

We implement nationally recognized protocols for infection prevention, medication safety, and fall reduction. Standardized checklists, handoff tools, and double-verification processes help reduce variability in care and ensure consistent adherence to safety standards for every patient.

### Disparities in Safety Outcomes

Data on adverse events, near misses, and infection rates are reviewed by language, race, ethnicity, and other demographic factors to identify disparities. Targeted interventions—such as enhanced education for patients with limited English proficiency or additional mobility support for high-risk populations—help ensure safety practices are effective for all.

### Transitions & High-Risk Care

We prioritize safe handoffs during care transitions by using structured communication tools and involving patients and families in the process. High-risk situations, such as medication changes or discharges to home with complex needs, trigger additional safety checks and follow-up to prevent harm after discharge.

### Patient & Family Involvement

Patients and families are encouraged to speak up about safety concerns, ask questions, and participate in care decisions. Feedback from our Patient and Family Advisory Council has informed changes to consent forms, signage, and safety education materials to improve clarity and accessibility.

### Performance Monitoring & Commitment

We monitor safety performance using incident reporting trends, infection control data, fall rates, and

patient feedback. Findings are shared with staff and leadership to guide ongoing improvements. By embedding safety into every process and reviewing outcomes through a person-centered lens, we ensure all patients—regardless of background—receive the highest standard of safe, reliable care.

#### Addressing patient social drivers of health

##### Performance in the Priority Area of Addressing Patient Social Determinants of Health

Our hospital recognizes that social and economic factors—such as housing stability, food security, transportation access, and health literacy—play a critical role in patient health outcomes.

Addressing these social determinants of health (SDOH) is essential to providing whole-person care.

##### Screening & Identification

We screen patients for key SDOH needs during admission, outpatient visits, and discharge planning.

Screening questions are integrated into our electronic health record, enabling care teams to document needs and coordinate appropriate resources in real time.

##### Resource Navigation & Community Partnerships

Patients with identified needs are connected to social workers, case managers, and community health workers who assist with navigating benefits, scheduling follow-up care, and linking to resources. We partner with community organizations, food banks, housing agencies, and transportation providers to ensure patients have access to the services required for recovery and long-term wellness.

##### Addressing Barriers to Care
